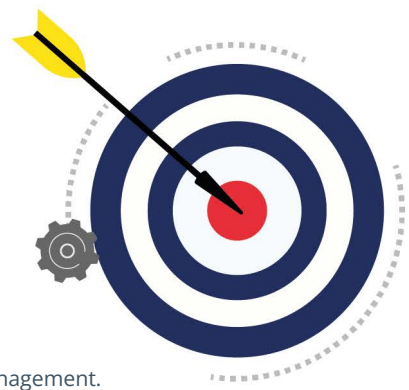

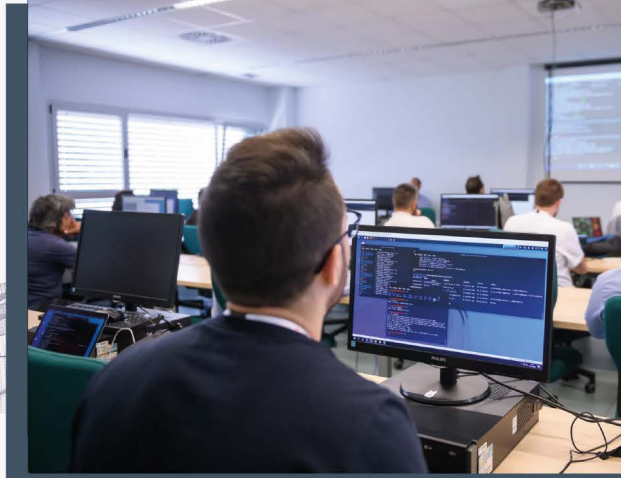


OTHER ACTIVITIES
